COMMENTS OF FOXCO ACQUISITION SUB, LLC

FoxCo Acquisition Sub, LLC ("FoxCo"), the corporate parent of the licensee of television station KSTU(TV), analog channel 13 and KSTU-DT, pre-transition DTV channel 28, and permittee of KSTU-DT, post-transition DTV Channel 13, Salt Lake City, Utah, by its attorneys and pursuant to Sections 1.415, 1.419 and 1.420 of the Commission's Rules (47 C.F.R. §§ 1.415, 1.419, 1.420), hereby submits these comments regarding the above-captioned *Notice of Proposed Rule Making* ("Notice") released July 18, 2008.¹ The *Notice* seeks comment on FoxCo's request, as set forth in its *Petition for Rule Making* dated June 19, 2008 ("*Petition*"), that the Commission amend the post-transition DTV Table of Allotments to substitute Channel 28 as the post-transition channel in lieu of Channel 13.

¹ The *Notice* references FoxCo Acquisition Sub, LLC as the proponent of the proposed rulemaking. FoxCo Acquisition Sub, LLC consummated the assignment of license for the station from Fox Television Stations, Inc. on July 14, 2008. See FCC File No. BALCT-20080110ACC. By subsequent *pro forma* application, Community Television of Utah License, LLC became the direct licensee of the station. See FCC File No. BALCT-20080604AAH.


