Dear Ms. Dortch:

US South Communications, Inc. d/b/a US South and d/b/a INCOMM ("US South") herewith files an original and four (4) copies of its calling card service provider report and certification for the 3rd quarter of 2008. A redacted version of this report is being filed via ECFS.

US South Communications, Inc. requests that the data contained in this report be afforded confidential treatment and not disclosed to the public under any circumstances pursuant to 47 C.F.R. Sections 0.459, 52.17, 54.711 and 64.604 of the Federal Communication Commission's ("FCC") Rules. The data contained in this reports is privileged and confidential and public disclosure of such information would likely cause substantial harm to the competitive position of US South in the marketplace.

Section 552(b)(4) of the FOIA and 47 U.S.C. Section 0.457(d) exempt this type of data from public disclosure.¹ Therefore, US South Communications, Inc. requests that this data be accorded confidential treatment.

Should the FCC deny this request for exemption from disclosure for any reason, US South
