Charles Crawford petitions the Commission to deny the application for minor change in licensed facility in BPH-20080AEC. The Commission has said: "We note that a party choosing to dismiss a rulemaking petition and refile as an application may adversely affect its position with respect to earlier filed petitions for rulemaking or earlier simultaneously filed applications." Revision of Procedures Governing Amendments To FM Table of Allotments and Changes of Community of License in the Radio Broadcast Service, Report and Order, released November 29, 2006, paragraph 14. The subject application - as of the date of filing on July 11, 2008 - is tantamount to dismissal of Tichener License Corporation's interest in MM Docket No. 02-212, adversely affecting its position vis-a-vis the earlier filed petition to allot an FM channel at Vinton, Louisiana.
