PLEADING CYCLE ESTABLISHED FOR PETITION OF THE FRONTIER LOCAL OPERATING COMPANIES FOR FORBEARANCE FROM ENFORCEMENT OF SECTION 69.5(a) OF THE COMMISSION'S RULES, SECTION 251(b) OF THE COMMUNICATIONS ACT AND COMMISSION ORDERS ON THE ESP EXEMPTION

By this Public Notice, we seek comment on a petition filed September 25, 2008 by the Frontier Local Operating Companies (Frontier) asking the Commission to forbear pursuant to section 160(c) of the Communications Act (Act), as amended, from "enforcing the ESP exemption, as adopted by Commission orders" and "section 69.5(a) of its rules to IP-originated voice traffic that terminates on the PSTN."¹ In addition, Frontier requests that the Commission "forbear from enforcing 47 U.S.C. section 251(b)(5) of the Act" on "non-local traffic terminated as voice traffic on the PSTN."²

Interested parties may file comments on the Frontier petition for forbearance on or before **October 10, 2008** and reply comments on or before **October 17, 2008** pursuant to sections 1.415 and 1.419 of the Commission's rules.³ Filings in this proceeding should be captioned "In the Matter of Petition of Frontier for Forbearance from Section 69.5 of the Commission's Rules, Section 251(b) of the Communications Act and Commission Orders on the ESP Exemption" and filed in WC Docket No. 08-205.

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.
 - For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. This Public Notice establishes certain procedural requirements relating to consideration of the Frontier petition for forbearance. This matter shall be treated as a "permit-but-disclose" proceeding in

accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
