


5. Justification of need for special temporary authority requested is attached hereto as Attachment 1.

Justification for need for continued special temporary authority requested.

IBFA Acquisition Company, LLC ("IBFA") hereby requests Continued Special Temporary Authority to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (the "Act") to continue operating under the authority granted by the Commission under Section 214 of the Act. The Applicant has previously submitted a Section 214 Application pursuant to Section 63.24(e) of the Commission's Rules, 47 C.F.R. § 63.24 (e) in File No. WC 08-81. This request for Special Temporary Authority is required because the underlying transfer described in the Section 214 Transfer of Control Application is pending and has not yet been granted.

Continued Special Temporary Authority should be granted because the Domestic 214 Application filed for the transfer of control of Kathleen Grabowski's Membership Interests in IBFA Acquisition Company, LLC to James Grabowski was released for Public Notice on September 23, 2008 with streamlined pleading cycle established. International authorization of the transfer of control of Kathleen Grabowski's Membership Interests in IBFA to James Grabowski was granted on September 26, 2008 in DA No. 08-2215.
