PETITION TO RECONSIDER MEDIA BUREAU ACTION  
DENYING  
PETITION TO DENY FILED BY CHARLES CRAWFORD  
DATED SEPTEMBER 24, 2008

1. Charles Crawford petitions the Commission to reconsider the Media Bureau's letter dated October 3, 2008 denying his petition dated September 24, 2008 styled "Petition to Deny the Minor Change of License Application for Winnie, Texas, and Amend FM Table of Allotments to Provide the channel for Vinton, Louisiana as proposed in MM Docket No. 02-212."

2. Mr. Crawford and Tichenor License Corporation have been engaged in an FM allotment contest between Vinton, Lousiana (of which Mr. Crawford is the proponent) and Winnie, Texas (of which Tichenor is the proponent). That contest, dating back to 2002, is currently pending before the Commission for decision in response to Mr. Crawford's Application for Review filed December 20, 2004.

3. Under such circumstances, Tichenor chose to file a second and inconsistent application for license of the Winnie facility citing DA-04-1200 while electing to retain its pursuit

of the Winnie license advanced in the litigation with Mr. Crawford's Vinton proposal in MM Docket No. 2-212. In short, Tichenor wants to have it both ways and the subject ruling by the Media Bureau buys the strategy on the ground that Tichenor was merely doing what the Commission expected it to do.

4. Well, not quite. If that were the case, the Commission would be ignoring the still pending multi-year litigation between these two parties over a mutually exclusive choice of preferred use of the frequency in the public interest.


