





* Iridium Communications Inc. will hold a direct voting and equity interest of approximately 53 percent and aggregate indirect voting and equity interests of approximately 47 percent in Iridium Holdings LLC. The indirect interests will be held through two wholly-owned intervening entities -- Baralonco, N.V., a Netherlands Antilles corporation, and Syncom Iridium Holdings Corp., a U.S. corporation -- which are not depicted here. Approximately 0.6 percent of the voting and equity interests of Iridium Holdings LLC will be indirectly owned by E.ON AG, a German corporation, also not depicted here.
