REPLY COMMENTS

Synergy Media, Inc. ("Synergy"), by its attorneys, hereby submits this reply in the above-captioned proceeding.

Synergy is the licensee of FM broadcast station WMLQ, Manistee, Michigan. The proponent in this proceeding, Roy E. Henderson, desires a new allotment on Channel 274A at Ewart, Michigan. In order to accommodate this proposal, WMLQ would have to change from its current frequency, Channel 249A, to Channel 282A. Mr. Henderson specified that he would reimburse Synergy for its "reasonable and prudent" out-of-pocket expenses incurred in making this change.

Mr. Henderson reaffirmed this commitment in his May 2 "Comments in Support."

Synergy has no objection to Mr. Henderson's proposal. However, Synergy is submitting this Reply to state for the record that Synergy's "reasonable and prudent" expenses for this change in frequency – in addition to the typical items such as a new antenna and promotional materials – will have to include a new transmitter. WMLQ currently operates with a 1965

Collins transmitter for which parts are no longer available. The only way WMLQ can change to a different frequency would be to install a new transmitter and antenna.

With this qualification – that Mr. Henderson will reimburse Synergy for the cost of a new transmitter, new antenna and related promotional materials – Synergy has no objection to Mr. Henderson's proposal.
