Woods Communications Corporation ("Woods"), licensee of television station WCOV-TV, analog Channel 20, and permittee of WCOV-DT, DTV Channel 16, Montgomery, Alabama, by its attorneys and pursuant to Sections 1.415, 1.419 and 1.420 of the Commission's rules (47 C.F.R. §§ 1.415, 1.419, 1.420), hereby submits these Comments regarding the above-captioned Notice of Proposed Rule Making ("Notice") released November 20, 2008. The Notice seeks comments on Woods' request, as set forth in its Petition for Rule Making ("Petition"), that the Commission amend the post-transition DTV Table of Allotments to substitute Channel 20 as the post-transition channel in lieu of Channel 16.
