JOINT STATUS REPORT

Comcast Corporation (“Comcast”) and TCR Sports Broadcasting Holding, L.L.P., d/b/a Mid-Atlantic Sports Network (“MASN”), by their attorneys and pursuant to the Order released by the Chief Administrative Law Judge (“ALJ”) on February 2, 2009,¹ hereby submit a Joint Status Report in the above-captioned proceeding. This Joint Status Report is being submitted without prejudice to the right of either party to bring any disputes to the ALJ for resolution.

(1) **Protective Order** – Comcast and MASN have reached agreement on a proposed Protective Order in this proceeding and are submitting concurrently herewith a joint motion for adoption of the Protective Order.

(2) **Document Discovery** – The parties have exchanged Requests for the Production of Documents and are working cooperatively to resolve outstanding issues related thereto.

Without prejudice to their ability to seek any relief necessary in the event of an impasse, the parties are optimistic that the limited issues outstanding at this time can be resolved through continued discussions.

(3) ***Depositions Discovery*** – Comcast and MASN have been working to determine available dates when witnesses will be available for depositions. Firm dates have not yet been established.

(4) ***Items Appropriate for Future Status Conference*** – At this time, the parties have not identified any specific issues that would require a future pre-hearing conference.
