This is to inform you that Susan Eid, Bill Little (by telephone), and undersigned counsel on behalf of The DIRECTV Group, Inc. ("DIRECTV"), and James Barker of Latham & Watkins on behalf of the DTVPR Trust, met today with Bob Ratcliffe, Sarah Whitesell, Mania Baghdadi, Royce Sherlock, William Beckwith, Rebekah Goodheart, and Kristi Thompson from the Media Bureau, and Jim Bird, Neil Dellar, and Joel Rabinovitz from the Office of General Counsel. In this meeting, the parties discussed DIRECTV's efforts to sever the attributable interests between DIRECTV Puerto Rico Ltd. ("DTVPR") and Liberty Cablevision Puerto Rico, Ltd. ("LCPR"). They focused particularly on the attached draft agreement for a non-attributable trust arrangement.

Pursuant to the Second Protective Order adopted in this proceeding on July 10, 2007, DIRECTV has designated the draft trust agreement as "Highly Confidential" and is not submitting it for the public record. DIRECTV is filing one copy of the draft agreement with the Secretary's office under separate cover, and two copies with Royce Sherlock of the Media Bureau. Under the terms of the Second Protective Order, these documents should not be placed in the public record in this proceeding.
