COMMENTS

Legend Communications of Wyoming, LLC ("Legend") hereby submits its Comments in the above captioned proceeding. *See Notice of Proposed Rule Making (NPRM)*, DA 09-42, released January 16, 2009. In response to a Petition for Rule Making filed by Legend, the *NPRM* proposes to allot Channel 267A at Ten Sleep, Wyoming in order to maintain that community's first local service.² Legend hereby reaffirms its interest in maintaining a first local service at Ten Sleep, Wyoming as stated in its Petition for Rule Making.³ If this Petition and Legend's pending application for Channel 267A at Ten Sleep are granted, Legend will construct the facilities as authorized.

Accordingly, Legend urges the Commission to grant this Petition in order to maintain a first local service at Ten Sleep and thereby provide a first local service to Manderson, WY.




