
Dear Ms. Dortch:




# Systematic Removal of Landlines

- **TCU**
  - Land lines left in with dial tone, no phone, hoping to limit liability, 2 new dorms being built with no land lines installed
- **Kentucky**
  - Land lines removed in all dorms
- **Texas Tech**
  - One phone on each floor, emergency phones outdoors, not used
- **U of Cincinnati**
  - Land lines removed




