Dear Ms. Dortch:

Ayersville Telephone Company hereby notifies the Commission that on July 1, 2009 Ayersville Telephone will begin offering Wireline Broadband Internet Access (WBIAS) on a permissively detariffed common carrier basis and discontinue offering common carrier WBIAS on a tariffed basis from the National Exchange Carrier Association Tariff F.C.C. No. 5. Neither the provisioning of nor the rates for these services will be affected by this action. In other words, the rates for these services will continue to be the effective rates contained in the National Exchange Carrier Association Tariff F.C.C. No. 5, unless and until customers device to change the terms of their service plan. Those revised terms and conditions under which WBIAS will be offered will also be available on the Ayersville Telephone website, (www.ayersvilletelco.com) effective July 1, 2009 and will also be available for review at Ayersville Telephone's business office located at 27932 Watson Road, Defiance, OH 43512. The geographic areas affected by this are the areas in which WBIAS is available in the Ayersville exchange of Ayersville Telephone Company.

This notice is also being provided to the Public Utilities Commission of Ohio, the Governor of the State of Ohio, and the Special Assistant for Telecommunications at the Department of Defense. A copy of the notification to the Ayersville Telephone Company's only customer for WBIAS (the non-regulated Internet Service Provider operation of the Company) is attached.


