

**APPLICATION**

Phone Services and More, LLC (“Phone Services and More,”) and Woodland Holdings, Corp. (“WHC”) (collectively the “Parties” or “Applicants”) hereby request authority pursuant to Section 214 of the Communications Act of 1934, as amended, and Sections 63.04 and 63.24(e) of the Commission’s Rules, to transfer control of domestic and international Section 214 authorizations held by Phone Services and More, as a result of the planned acquisition of Phone Services and More, by WHC. Phone Services and More shall remain intact as a surviving company (hereinafter referred to as “Surviving Company”); as a wholly owned subsidiary of WHC. This application is in accordance with a Purchase Agreement between the Parties to be concluded once the transfer of the 214 has been completed.

The Applicants respectfully request streamlined treatment of this Application pursuant to Sections 63.03 and 63.12 of the Commission’s Rules. This Application is eligible for streamlined processing pursuant to Section 63.03 of the Commission’s Rules as the because: (1) both applicants are non-facilities based carriers; (2) the proposed transaction will result in Surviving Company having a market share in the interstate, interexchange market of less than ten (10) percent; This Application also qualifies for streamlined treatment under Section 63.12 because, in accordance with Section 63.12(c): (1)

Surviving Company will not be affiliated with any foreign carriers; (2) Surviving Company will not be affiliated with any dominant U.S. carrier; and (3) no authority is requested to provide switched basic services over private lines to a country for which the Commission has not previously authorized the provision of switched services over private lines.

In support of its Application, the Parties provide the following:

## **I. APPLICANTS**

### **A. Phone Services and More, LLC**

Phone Services and More, is a Michigan Limited Liability Company with an office at 301 Hoover Blvd., First Floor, Holland, MI 49423. Phone Services and More, is a non-facilities based long distance voice service provider. Phone Services and More, is authorized to provide services via its international and domestic 214 authority.

### **B. Woodland Holdings, Corp.**

WHC is a Delaware Corporation with an office at 301 Hoover Blvd., First Floor, Holland, MI 49423. WHC is a newly created company for the purpose of purchasing Phone Services and More, and other complimentary businesses.

## **II. DESCRIPTION OF THE TRANSACTION**

Phone Services and More, has agreed to sell 100% of its business to WHC under the terms set forth in their purchase agreement ("Agreement"). Pursuant to the terms of the Agreement, WHC will hold 100% percent ownership interest in the Surviving Company. The Surviving Company will have a Board of Directors comprised of four directors. The four directors will be appointed by WHC. Following receipt of necessary approvals, the Surviving Company will continue to provide the services offered by the Applicants.

## **III. PUBLIC INTEREST STATEMENT**

The purchase of Phone Services and More, by WHC will enable existing services to continue to be offered as well as additional services to be added. WHC anticipates a consistent growth in revenue and expects to increase the number of employees starting in 2008. Planned development work and possible partnership agreements will improve the breath of service offered to customers. Customers will continue to receive the same high-quality telecommunications services.






