In one meeting, the Commission participants were Rebekah Goodheart, Royce Sherlock, Rosalee Chiasa, Marcia Glauberman, Debra Sabourin, Elvis Stumbergs, William Beckwith, Julie Salovaara, Mania Baghdadi (by speakerphone) and Roy Stewart of the Media Bureau, Gardner Foster of the International Bureau, and Joel Rabinovitz of the Office of the General Counsel. In the other meeting, the Commission participants were Rick Chessen and Jamila Bess-Johnson of the Office of Acting Chairman Copps.

In the meetings, the undersigned addressed the above-referenced proceeding in general, and, in particular, the issues raised by ROI in the Comments it submitted in this proceeding. ROI addressed and responded to questions concerning the advertising market, the lack of capital in the market place, and the resources necessary for any entity to operate successfully the channels that Sirius-XM propose to lease. ROI also offered its opinions on, reasoning for, and responded to questions concerning the following subjects: the type of programming that would be offered, what entities should qualify to seek these channels, and whether Sirius-XM or an independent board appointed by Sirius-XM should undertake the selection process subject to Commission review.
