COMMENTS

College Creek Media, LLC ("College Creek") hereby submits its
Comments in the above-captioned proceeding. *See Notice of Proposed Rule Making*
(*"NPRM"*), DA 09-836, released April 17, 2009. In support of its position, College
Creek submits the following:

In response to a Petition for Rule Making filed by College Creek, the
NPRM proposes the following change to the FM Table of Allotments: the channel of the
vacant allotment at Cut Bank, Montana be changed from Channel 274C1 to Channel
265C1.¹ College Creek is permittee of Station KEAU(FM), Fairfield, Montana.² The
proposed change is necessary to eliminate the short-spacing between Station KEAU's
authorized site and vacant channel 274C1 at Cut Bank. College Creek hereby reaffirms
its interest in having the above-referenced channel substitution made at Cut Bank,



Montana. Substituting Channel 265C1 at Cut Bank will prevent potential interference problems and permit future auction applicants for Cut Bank to provide fully-spaced sites.

Accordingly, in view of the above, College Creek respectfully requests the Commission to substitute Channel 265C1 at Cut Bank, Montana.


