Dear Ms. Dortch:

Waller, Inc. ("Waller"), Bruce Telephone Company, Inc. ("Bruce"), WWC, Inc. d/b/a Solution Long Distance ("WWC") and Fail, Inc. ("Fail", and collectively with Waller, Bruce, WWC, the "Applicants"), pursuant to section 214 of the Communications Act, as amended 47 U.S.C. § 214, and Section 63.04 of the Commission's Rules, 47 C.F.R. § 63.04, filed an application for transfer of control (the "Application") in the above-referenced proceedings.

On behalf of the Applicants, this will supplement the information previously filed with the Commission. Applicants state in Section II(a)(9) of the Application that:

"In addition to this Application, Applicants have and/or will file two (2) FCC Forms 603 with the Commission's Wireless Telecommunications Bureau. The first is for the Assignment of Authorization from Waller to Fail of three (3) 700 MHz Lower Band (Blocks C, D) licenses (Call Signs WPWV535, WPWV536, AND WPWV537)."

This supplement is to inform you that the application for Assignment of Authorization will be filed on behalf of Waller, as assignor, naming Waller Wireless, Inc. ("Waller Wireless"), as assignee, rather than Fail. As discussed in the Application, Waller Wireless is a subsidiary of Waller and currently provides high-speed Internet services over these 700 MHz licenses. Upon consummation of the proposed transaction, Waller Wireless will become a subsidiary of Bruce. Fail will be the real party-in-interest as the parent of Bruce.
