**NINETEENTH CONSOLIDATED STATUS REPORT  
OF INTRADO COMMUNICATIONS OF VIRGINIA INC.**

Intrado Communications of Virginia Inc. (“Intrado Comm”), by its attorneys, respectfully submits this Nineteenth Consolidated Status Report in response to the request from staff of the Wireline Competition Bureau (“Bureau”) of the Federal Communications Commission (“Commission” or “FCC”). This report provides information regarding the status of negotiations between Intrado Comm and Central Telephone Company of Virginia and United Telephone - Southeast, Inc. (collectively, “Embarq”), including the status of other state arbitration proceedings pending between Intrado Comm and Embarq. There have been no further regulatory developments regarding the Intrado Comm/Embarq arbitrations since the Eighteenth Consolidated Status Report.

This report also provides information regarding the status of negotiations between Intrado Comm and Verizon North Inc., Verizon Florida, LLC, and Verizon Virginia Inc. (collectively,

“Verizon”), including the status of other state arbitration proceedings pending between Intrado Comm and Verizon. On August 13, 2009, Verizon filed its Motion to Add Issues and Establish a New Hearing Date with the Florida Public Service Commission (“Florida PSC”). The Motion is set forth as **Attachment 1**. Intrado Comm filed a Response to Verizon’s Motion on August 19, 2009. Intrado Comm’s Response to is set forth as **Attachment 2**. A pre-hearing conference with the Florida PSC was schedule for August 20, 2009 in the Intrado-Verizon arbitration. In response to the request of the Parties, on August 24, 2009, the Florida PSC issued an Order cancelling the pre-hearing conference and granted a 60-day extension of the pre-hearing conference and hearing. The Order indicated that new procedural dates would be established at a later time. The Florida PSC Order is set forth as **Attachment 3**. In the interim, Intrado Comm has further discovery from the Florida PSC Staff and Verizon. Verizon, likewise, has been served with discovery from the Florida PSC and Intrado Comm.

In addition, on August 19, 2009, the Public Utilities Commission of Ohio (“PUCO”) granted Verizon’s application for rehearing, filed July 24, 2009, of the Intrado Comm-Verizon Ohio arbitration award that was issued by the PUCO on June 24, 2009. The PUCO Order is set forth as **Attachment 4**. The actually ruling on the substance of Verizon’s request is yet to be addressed.
