This certification is provided pursuant to 47 C.F.R. §§ 54.313 and 54.314. On behalf of Sprint Nextel Corporation ("Sprint Nextel"), I hereby certify, under penalty of perjury, that all high-cost universal service support provided to Sprint Nextel for the 2010 calendar year will be used only for the provision, maintenance and upgrading of facilities and services for which the support is intended, pursuant to Section 254(e) of the Telecommunications Act of 1996.

The Louisiana Public Service Commission ("LPSC") issued Order No. U-29954 on March 29, 2007 consolidating the previous eligible telecommunications carrier ("ETC") designations of Sprint (Order No. U-27509) and NPCR, Inc. (Order No. 27289) and expanding these existing designations. Sprint Nextel was subsequently certified as an ETC with the FCC and USAC. Sprint Nextel's eligibility to receive continued ETC support for the 2010 calendar year is dependent upon the Louisiana Public Service Commission ("Commission") providing re-certification of Sprint Nextel's eligibility to the Federal Communications Commission ("FCC") and the Universal Service Administrative Company ("USAC") on or before October 1, 2009. See 47 C.F.R. §§ 54.313(d)(3)(i) and 54.314(d)(1).

Accordingly, Sprint Nextel hereby requests that the Commission transmit a letter to the FCC and USAC to provide for the certification. Please reference SAC No. 279008 (Sprint) and 279006 (NPCR, Inc.) in the certification transmittal to USAC. The letter will need to be received by the FCC and USAC on or before October 1, 2009 to be effective.
