**Re: Authorization to Include Previously-Filed Materials in GN Docket Nos. 09-47 and 09-137**

Dear Ms. Dortch:

On behalf of Cable One, Inc. (“Cable One”) and in response to a request from Media Bureau staff, this letter provides authorization for the Highly Confidential materials submitted by Cable One on November 12, 2009 to be included in GN Docket Nos. 09-47 and 09-137.<sup>1</sup>

Specifically, pursuant to the Protective Order released on November 16, 2009, Cable One is submitting for inclusion in: GN Docket No. 09-47 (*International Comparison and Consumer Survey Requirements in the Broadband Data Improvement Act*); and GN Docket No. 09-137 (*Inquiry Concerning the Deployment of Advanced Telecommunications Capability to All Americans in a Reasonable and Timely Fashion, and Possible Steps to Accelerate Such Deployment Pursuant to Section 706 of the Telecommunications Act of 1996, as Amended by the Broadband Data Improvement Act, A National Broadband Plan for Our Future*) the Highly Confidential Information it previously submitted on November 12, 2009 in GN Docket No. 09-51 (*A National Broadband Plan for our Future*). We hereby incorporate the information from GN Docket No. 09-51 by reference into GN Docket No. 09-47 and GN Docket No. 09-137.

Cable One understands that its November 12, 2009 submission, as incorporated, will be subject to the full protections of the “Revised Protective Order”<sup>2</sup> even though it was filed in


