

**NOTICE OF WITHDRAWAL OF PETITION FOR STAY**

Aventure Communication Technology, L.L.C. (“Aventure”), by its undersigned counsel provides this notice to the Commission that it is withdrawing its Petition seeking stay of a Final Order issued by the Iowa Utilities Board (“IUB”). Aventure filed its Petition on October 6, 2009, seeking emergency stay of an order issued by the IUB, because the order threatened imminent and irrevocable harm to Aventure. Since that time, the IUB has voluntarily retracted the provision of its order that would have imposed such harm. As a result, the Aventure Petition to stay the IUB order is no longer necessary, and is hereby withdrawn.

Aventure reserves its right to seek relief from this Commission regarding the IUB order in the future, should additional developments require such relief.
