SC TxLink, LLC ("Transferor" or "SC TxLink") (FRN 0013216833) and SCTxLink Acquisition Group, LLC ("Transferee" or "SCTxLink Acquisition Group") (FRN 0019419746) (collectively "Applicants"), by their undersigned attorney and pursuant to Section 214 of the Communications Act of 1934 (the "Act"), as amended, 47 U.S.C. § 214, and Section 63.04 of the Commission's Rules, 47 C.F.R. § 63.04, hereby respectfully seek Commission approval to transfer control of SC TxLink to SCTxLink Acquisition Group. Streamlined processing of this application is requested pursuant to Section 63.03 of the Rules, 47 C.F.R. § 63.03. Applicants provide below the information required by Section 63.04 of the Commission's Rules, 47 C.F.R. § 63.04.

**(5) Anti Drug Abuse Act of 1998 Certification**

By the attached certification, Applicants certify pursuant to 47 C.F.R. §§ 1.2001-1.2008 of the Rules that no party to the application is subject to a denial of Federal benefits pursuant to section 5301 of the Anti-Drug Abuse Act of 1988.

**(6) Description of the Transaction**

*The Parties.* SC TxLink holds blanket domestic Section 214 authority to provide interstate telecommunications services. SC TxLink is a provider of competitive local exchange and interexchange services and began offering service in 2007. SC TxLink is currently authorized to provide competitive local exchange and/or interexchange services in New York and Texas. Of those states, SC TxLink is currently providing service in Texas. SCTxLink Acquisition Group was recently formed by its principals to purchase SC TxLink, and to consolidate SC TxLink with other competitive local exchange carriers. SCTxLink Acquisition Group itself is not a provider of telecommunications services.

*The Transaction.* Pursuant to the terms of an Interest Purchase Agreement, SCTxLink Acquisition Group will purchase 100% of the equity interests of SC TxLink, which will become a wholly owned subsidiary of SCTxLink Acquisition Group. For the Commission's convenience, pre- and post-closing organization illustrative charts are provided as Exhibit A. The transfer of control of SC TxLink will involve no disruption, impairment, or other changes in the entity providing service to customers, the facilities used to provide such services, or the rates, terms and conditions of such service. All existing tariffs will remain in place. In addition, the contact points for customers and Commission inquiries will remain the same after the transfer of control. All existing customer service numbers/operations, contracts and procedures of SC TxLink will remain in place after the transaction, including procedures relating to billing and repair complaints.

Although the transaction will result in a change in the control of SC TxLink, no assignment of authorizations, assets, or customers will occur as a consequence of the transaction. SC TxLink will continue to provide service to SC TxLink existing customers pursuant to SC

TxLink authorizations under the same rates, terms and conditions. Accordingly, this transaction will be transparent to the customers of SC TxLink.

**(7) Description of Geographic Service Area and Services in Each Area**

*Transferor.* SC TxLink, LLC currently provides domestic resold intrastate and interstate telecommunications services on a retail basis in the following states: Texas. SC TXLink is affiliated with the following companies: Dial Tone & More, Inc.; BLC Management, LLC d/b/a Angles Communication Solutions; and Ren-Tel Communications, Inc., all of which are wholly owned by Brian Cox, the owner of SC TXLink. These companies are simultaneously filing similar Applications for Approval of Transfer of Control.

*Transferee.* SCTxLink Acquisition Group, LLC does not provide any domestic telecommunications services in the United States in its own right. Applicants' affiliates provide domestic resold intrastate and interstate telecommunications services on a retail basis as small CLECs in the following states: Alabama; Arkansas; Florida; Georgia; Indiana; Kentucky; Louisiana, Mississippi, Missouri, North Carolina; South Carolina; Tennessee; and Texas.

**(8) Qualification for Streamlining**

This Application is eligible for streamlined processing pursuant to Section 63.03(b)(2)(i) of the Commission's Rules, 47 C.F.R. § 63.03(b)(2)(i) for the following reasons: (1) SC TxLink and SC TxLink affiliates, as defined in Section 3(1) of the Communications Act ("Affiliates"), combined hold less than a ten percent (10%) share of the interstate, interexchange market;<sup>1</sup> (2) SC TxLink and SC TxLink Affiliates provide competitive local exchange service only in areas served by dominant local exchange carriers (none of which is a party to the proposed

transactions), and; (3) neither SC TxLink nor any of SC TxLink Affiliates is dominant with respect to any service.

**(9) Other Pending Commission Applications**

**(10) Special Consideration**

None.

**(11) Waiver Requests (If Any)**

None.

**(12) Public Interest Statement**

Applicants submit that the transaction will serve the public interest because it brings SCTxLink Acquisition Group's experienced management team to enhance SC TxLink's ability to provide quality local exchange services to its customers. The acquisition will enable SC TxLink to obtain access to additional financial and operational resources from its new parent company. The transfer of control will ensure the ongoing provision of high quality telecommunications to the public, the introduction of new services, and will promote competition in the U.S. telecommunications integration service market for the benefit of all consumers. As evidenced by this application's eligibility for streamlined processing, transactions such as these do not raise anticompetitive concerns for the Commission.<sup>2</sup> Neither Applicant is (or is affiliated with) an ILEC.




**PRE- AND POST-CLOSING ORGANIZATIONAL CHARTS**
