## DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF REN-TEL COMMUNICATIONS, INC. TO REN-TEL ACQUISITION GROUP, LLC

### STREAMLINED PLEADING CYCLE ESTABLISHED

On December 21, 2009, Ren-Tel Communications, Inc. (Ren-Tel) and Ren-Tel Acquisition Group, LLC (Ren-Tel Acquisition Group) (together, Applicants) filed an application pursuant to section 63.03 of the Commission's rules to transfer control of Ren-Tel to Ren-Tel Acquisition Group.<sup>1</sup> Ren-Tel, a Georgia corporation, currently provides resold competitive local exchange (LEC) and interexchange services in Missouri. Ren-Tel is wholly owned by Brian Cox, a U.S. citizen.

Ren-Tel Acquisition Group, a Delaware limited liability company, does not currently provide telecommunications services and was formed to purchase Ren-Tel and consolidate it with other competitive LECs. Ren-Tel Acquisition Group is owned by Associated Telecom Management Services, LLC, a Delaware limited liability company, that is, in turn, owned by Thomas Biddix, a U.S. citizen. Applicants state that no other entity holds a direct or indirect interest in Ren-Tel Acquisition Group.<sup>2</sup> Pursuant to the terms of the proposed transaction, Ren-Tel Acquisition Group will purchase 100 percent of the equity interests of Ren-Tel, which will become a wholly owned subsidiary of the company.

Applicants state that the transactions do not involve any incumbent LEC services and that, in the states in which these entities have overlapping operations, there are multiple competitive alternatives.

Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.<sup>3</sup>

## GENERAL INFORMATION

The Wireline Competition Bureau finds, upon initial review, that the transfer of control identified herein is acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 C.F.R. § 63.03(a), interested parties may file comments **on or before February 10, 2010**, and reply comments **on or before February 17, 2010**. Unless otherwise notified by the Commission, the Applicants may transfer control on the 31<sup>st</sup> day after the date of this notice.<sup>4</sup> Comments must be filed electronically using (1) the Commission's Electronic Comment Filing System (ECFS) or (2) the Federal Government's e-Rulemaking Portal. See 47 C.F.R. § 63.03(a) ("All comments on streamlined applications shall be filed electronically . . ."); *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- Comments may be filed electronically using the Internet by accessing the ECFS, <http://www.fcc.gov/cgb/ecfs/>, or the Federal e-Rulemaking Portal, <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
