WEST KENTUCKY RURAL TELEPHONE COOPERATIVE CPNI USAGE POLICY STATEMENT

Pursuant to Section 64.2009(e) of the Federal Communications Commission's rules this statement explains how West Kentucky Rural Telephone Cooperative's operating procedures ensure compliance with Part 64, Subpart U, of the FCC's rules.

The company has policies procedures in effect that protect the usage and dissemination of CPNI. CPNI is only accessible by authorized personnel, who interface directly with customers, in the customary course of business.

The company has written instructions on accessing, usage, and protection of CPNI.

Company personnel that have access CPNI have been trained in its use, and protection.

Call detail information is generally not available to customers. Call detail information is only provided pursuant to a written request validated by authorized management personnel.

Customers that access the company center in person must disclose a valid photo ID to access their call records. Telephone access is provided with name and address, and call detail information is only provided, with written consent. There is no on-line access available to consumers at the present time.

Procedures are in place for all marketing material prior to implementation to be reviewed by supervisory personnel and executives to ensure that CPNI data if used is properly protected, and if required, notice and authorization provided by its customers. No marketing activities were engaged in 2009 that used CPNI.

The company does not released CPNI information to third parties for marketing or any other purpose.

Employees that may misuse CPNI information are subject to disciplinary action as specified in the Company Employee Manual. An affirmation statement is required by all new employees that they have read the Manual and understand its terms.

There are no security CPNI breaches to report.
