Dear Ms. Dortch,

On Monday April 19, 2010 Andrew Jay Schwartzman of Media Access Project, Cecilia Garcia of The Benton Foundation, Ben Lennett of the New America Foundation, Meredith McGehee of the Campaign Legal Center and Angela Campbell, Adrienne Biddings and Erika Stallings of the Institute for Public Representation, on behalf of the Public Interest Public Airwaves Coalition (“PIPA”), met with Commissioner Mignon Clyburn and her Legal Advisor, Angela Kronenberg, to discuss the above referenced proceeding.

PIPA expressed concern that the *Enhanced Disclosure Order* and other public interest requirements have not been a priority for the FCC. PIPA urged the Commission to act on the pending petitions for reconsideration so that the Commission can begin realizing the significant data gathering benefits that come with enhanced disclosure. This increased availability of useful data will help ensure that broadcasters’ public interest obligations are properly addressed and will aid the Commission in other proceedings.

PIPA also urged the Commission to separate the online public file requirement from the Form 355 requirement and to promptly implement the online public file rule. PIPA stressed the

importance of ensuring that the public had access to information about their local broadcasters, since television remains a major source of news and information for many citizens.
