

Dear Valued Customer:

Hill Country Telecommunications, LLC, d/b/a Hill Country Long Distance, in order to more efficiently and better serve its valued customers, will assume effective June 1, 2010, direct responsibility for the provision of long distance service currently provided by our affiliate, Hill Country Telephone Cooperative, Inc., d/b/a Hill Country Long Distance. If you currently subscribe to Hill Country Long Distance, this change may require further action (as detailed below). Otherwise, this change does not affect your services or rates.

You may choose another carrier for your long distance telephone service, subject to any termination restrictions in your current contract. Unless you elect to change your carrier, no action is required by you and you will continue to receive the same, excellent services without interruption. You will not be charged any carrier-change fees as a result of any changes made prior to June 1, 2010, or for the change from Hill Country Telephone Cooperative, Inc., d/b/a Hill Country Long Distance, to Hill Country Telecommunications, LLC, d/b/a Hill Country Long Distance.

If you have a freeze on your Hill Country Long Distance Service, that freeze will be automatically lifted on June 1, 2010, in order to complete the change. If you would like to re-apply this freeze, please contact our Business Office at the numbers provided below after June 1, 2010, to re-apply the freeze. Please note that any "freeze" you have placed on your existing telephone numbers to prevent unauthorized transfer to another long distance carrier will be over-ridden for purposes of this transaction, and will need to be reinstated by you after the transfer is complete.

Providing excellent and uninterrupted service to our valued customers continues to be our top priority. Your existing rates, configuration and billing for Hill Country Long Distance will remain the same, with no changes.
