APPLICATION

Pursuant to Section 214 of the Communications Act of 1934, as amended (47 U.S.C. § 214) and Section 63.04 of the Commission's Rules (47 C.F.R. § 63.04), Joseph S. Fernandez ("Transferee"), on behalf of himself and Manuel Torrens ("Transferor"), respectfully requests Commission approval or authority as may be necessary to enable Transferor and Transferee to consummate a transaction whereby Mr. Fernandez will acquire control of Easy Telephone Services Company ("Easy Telephone" or "Licensee").

Licensee provides interstate telecommunication service, including exchange access service. The proposed transaction will result in a change in the direct ownership of Licensee. There will be no transfer of authorizations, assets or customers as a result of the proposed transaction. Licensee will continue to provide service to its existing customers pursuant to its authorizations under the same name and under the same rates, terms and conditions.

(a)(5) Applicants certify that they are not subject to a denial of Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1998. See 21 U.S.C. § 862.

(a)(6) The transaction is a transfer of control of the Licensee whereby Mr. Torrens, a 60 percent owner of Licensee, will sell a majority of his equity in Licensee to Mr. Fernandez. As a result, Mr. Fernandez will be a 51 percent owner of Licensee and Mr. Torrens will be a 9 percent owner of Licensee. The Licensee, Easy Telephone, will continue to provide telecommunications services under its name and at the same rates, terms, and conditions as it did prior to the transfer of control.

(a)(7) The Transferor and Transferee are individuals. As such, they do not offer domestic telecommunications services and are not required to describe their services.

(a)(8) This Application is eligible for streamlined processing pursuant to Section 63.03 of the Commission's Rules (47 C.F.R. § 63.03). This Application is eligible for streamlined processing pursuant to Section 63.03(b)(1)(ii) because the Transferee is not a telecommunications provider.

(a)(9) Licensee does not hold any other authorizations or licenses from the Commission. Therefore, no other applications are being filed with the Commission with respect to this transaction.

(a)(10) No Applicant is requesting special consideration because it is facing imminent business failure.

(a)(11) No waiver requests are being sought in conjunction with this transaction.

(a)(12) The transaction described herein will serve the public interest. With a new majority owner, Easy Telephone will continue to provide high-quality domestic telecommunications services to its customers while being able to expand its customer base and provide new services. The transfer of control of Easy Telephone will not result in a change of carrier for customers or any assignment of authorizations. Furthermore, rates, terms, and conditions of services currently being provided by Easy Telephone to its customers will not change as a result of the transaction. The transaction will be seamless and transparent to consumers and Easy Telephone will continue to provide high-quality communications services to its customers without interruption.

II. CONCLUSION

For the reasons stated above, the public interest, convenience, and necessity would be furthered by a grant of this Application for the transfer of control of Easy Telephone Services Company.




