We write to confirm the status conference scheduled for Monday, June 28, 2010, at 1:00 p.m. EDT at Commission headquarters. The parties should come prepared to discuss: (i) any need to amend the pleadings; (ii) bifurcation of the proceedings; (iii) any discovery the parties believe is
