

On July 23, 2010, representatives of the Infrastructure Coalition (consisting of CTIA–The Wireless Association<sup>®</sup>, the National Association of Broadcasters, PCIA–The Wireless Infrastructure Association, and the National Association of Tower Erectors) and the Conservation Groups (consisting of the American Bird Conservancy, Inc., Defenders of Wildlife, and the National Audubon Society) met with Ms. Angela Giancarlo, Chief of Staff and Senior Legal Advisor to Commissioner Robert M. McDowell concerning the above docketed proceedings. A list of the meeting’s participants is attached.
