Names of the Parties to the Transaction: The acquiring carrier is Broadview Networks, Inc. The customers will be acquired from BBCentric.

Types of Telecommunications Services Provided to Affected Customers: The services being provided to the customers being transferred include local and long distance services of BB Centric in the State of New York.

Please note the following:


- If you opt to move your service to another provider prior to the end of the term of your existing contract with Broadband Centric, you may be responsible for early termination penalties.
