WIRELESS TELECOMMUNICATIONS BUREAU AND INTERNATIONAL BUREAU GRANT CONSENT FOR THE TRANSFER OF CONTROL AND ASSIGNMENT OF LICENSES AND AUTHORIZATIONS FROM AT&T INC. TO TEXAS 10, LLC

Pursuant to sections 214 and 310(d) of the Communications Act of 1934, as amended,¹ and sections 0.261 and 0.331 of the Commission's rules,² the Wireless Telecommunications Bureau and the International Bureau approve the following applications requesting Commission consent to the transfer of control of or the assignment of licenses and authorizations currently held by subsidiaries of AT&T Inc. ("AT&T") to Texas 10, LLC ("Texas 10"). No comments or petitions to deny were received in response to the Public Notice announcing that the applications had been accepted for filing.³ The Bureaus find, upon consideration of the record, that the proposed transfers and assignments will serve the public interest, convenience, and necessity.⁴
