As requested by FCC staff, the Applicants in the proceedings captioned above hereby provide the following additional information to supplement their Applications. Unless otherwise noted, the meaning of each capitalized term is as defined in the Applications.

Suddenlink Board Members. As previously stated in the Applicants' August 17, 2010 submission, Cequel Communications, LLC, doing business as Suddenlink Communications ("Suddenlink"), is a wholly owned indirect subsidiary of Cequel Communications Holdings I, LLC ("Cequel"). Cequel is a wholly owned subsidiary of Cequel Communications Holdings, LLC ("Cequel Holdings"). Cequel Holdings is an indirect subsidiary of Cebridge Connections Holdings, LLC ("Cebridge").

The Applicants clarify that the governing body of all of the entities that directly or indirectly control Suddenlink is Cequel Holdings, and the Board of Directors of Cequel Holdings is the only Board of consequence within the corporate structure that serves a substantive purpose. To the extent that any of the other entities within the corporate structure (including Suddenlink, Cequel, or Cebridge) has a Board of Directors, those Boards would be ministerial in nature, and would exist solely for corporate organizational purposes. Suddenlink ultimately acts solely at the direction of the Board of Directors of Cequel Holdings.

The Applicants further clarify that Michael Huber, a Managing Principal of the Quadrangle Group, and Amanda Siegel, a Principal of the Quadrangle Group, are members of the Board of Directors of Cequel Holdings. There are eleven (11) people in total on the Board of Directors of Cequel Holdings.

NTELOS Board Members. The Applicants further clarify that Michael Huber, a Managing Principal of Quadrangle Group, and Daniel Fine, a Vice President of Quadrangle Group, are members of the Board of Directors of NTELOS. There are eight (8) people in total on the NTELOS Board of Directors.
