SUPPLEMENT**

Dear Ms. Dortch:

Pursuant to Staff's request, Applicants hereby supplement the pending Application in the above-referenced proceeding. Applicants clarify that Fiber Technologies New York Networks, LLC, which holds a certificate to provide intrastate telecommunications services in New York, does not currently provide any telecommunications service and does not have any telecommunications customers. Applicants also agree to notify the Commission of the respective ownership percentages held collectively by certain members of the management of Fibertech Networks, LLC and by Court Square Capital Partners Investment Funds as of the closing of the pending transaction.

In addition, Applicants provide the following supplemental ownership information requested by Staff:

Court Square Capital GP, LLC ("GP") is owned by the investment professionals at Court Square Capital Partners ("Court Square"), each of whom is a United States citizen. No member of the GP (through its ownership in the GP or in combination with any other interest) will hold a 10% or greater interest in Firefox Acquisition Corp. The GP is managed and controlled by its Board of Managers ("Board") comprised of the following members of the GP: William Comfort, David Thomas, Michael Delaney, Joseph Silverstri, Ian Highet and John Weber, each of whom is appointed in the limited liability company agreement of the GP and each of whom will continue to serve on the Board so long as they remain investment professionals at Court Square. Decisions of the Board, including designation of replacement members, are made by the approval of a majority of the Board members. No member of the GP is affiliated with a telecommunications carrier other than Fiber Technologies Networks, L.L.C.
