Dear Mr. Hilding:

This is in response to the petition for rulemaking that you filed on November 13, 2009 (Petition). You request that Part 97 of the Commission's Rules be amended to prohibit the false or unauthorized use of an amateur radio call sign. For the reasons set forth below, we dismiss the Petition.

The Petition primarily expresses concern about the misappropriation of call signs on internet bulletin boards.<sup>1</sup> You state that this should be considered a form of identity theft, and you propose that Part 97 be amended to prohibit any misrepresentation or unauthorized use of someone else's amateur call sign "over the public airwaves, Internet packet cluster system posting, cellular or non-cellular telephone connections, electronic based communications or print media formats of any other nature."<sup>2</sup>

Part 97 of the Commission's Rules regulates only the amateur radio service. Regulations regarding other forms of communications would be beyond the scope of Part 97. Given that Part 97 already prohibits amateur stations from transmitting false identification,<sup>3</sup> we conclude that the rules already address the misuse of amateur call signs to the appropriate extent, and that your Petition presents no grounds for amending Part 97.

Accordingly, IT IS ORDERED, pursuant to Sections 4(i) and (j) and 303(r) of the Communications Act of 1934, as amended, 47 U.S.C. §§ 154(i), (j), 303(r), and Section 1.401(e) of the Commission's Rules, 47 C.F.R. § 1.401(e), that the petition for rulemaking filed by Eric Hilding on November 13, 2009, IS DISMISSED.

This action is taken under delegated authority pursuant to Sections 0.131 and 0.331 of the Commission's Rules, 47 C.F.R. §§ 0.131 and 0.331.

**PETITION FOR RULEMAKING**

Eric R. Hilding, hereinafter "Petitioner", respectfully  
Submits this *PETITION FOR RULEMAKING* to amend the FCC rules  
governing Amateur Radio Service.

1. Petitioner has been an FCC licensed amateur radio operator  
for more fifty (50) years, is an "Extra Class" licensee (K6VVA)  
and Amateur Radio "Emergency Responder" in his local community.

2. 47 CFR Part 97.3(a)(1) states:

*Amateur operator. A person named in an amateur  
operator/primary license station grant on the  
ULS consolidated licensee database to be the  
control operator of an amateur station.*

3. 47 CFR 97.5(b)(1) states:

*An operator/primary station license grant. One,  
but only one, operator/primary station license  
grant may be held by any one person. The primary  
station license is granted together with the  
amateur operator license.*

4. Therefore, the grant of an Amateur Radio operator/primary station license and callsign is actually a Federal Fingerprint and Federal identity that is unique to one, and only one, individual person or club entity, using the same principle as assignment of unique Federal Social Security numbers. Any unauthorized use or Identity Theft of a person's Social Security number is rightfully a Federal crime.

5. This Petition for Rulemaking proposes amending 47 CFR Part 97 to add the following provisions as Section 95.5(e) (1):

*Any misrepresentation or unauthorized use of a Federal Communications Commission licensee's unique callsign identity, whether made over the public airwaves, Internet packet cluster system postings, cellular or non-cellular telephone connections, electronic based communications or print media formats of any other nature, shall be considered a form of Federal Identity Theft and a Federal crime.*

6. Further, to add the following as Section 95.5(e) (2):

*Each single offense committed as a violation of any of the provisions of Section 95.5(e) (1) above shall carry a mandatory punishment of one (1) year in prison and a ten thousand dollar (\$10,000) fine per each fraudulent use of a Licensee's callsign identity. In any situation(s) where a licensee's callsign identity has been fraudulently used to make defamatory, political, profane, racial or slanderous comments, the mandatory punishment for each offense shall be five (5) years in prison and*

*a fifty-thousand dollar (\$50,000) fine. Should the offender be a current FCC licensee of any license class, such license and the ability to obtain any future FCC license of any type whatsoever shall be revoked for perpetuity.*

7. 47 CFR Part 97(e) reminds us all that a fundamental purpose of amateur radio is the "Continuation and extension of the amateur's unique ability to enhance international goodwill." Most unfortunately, over the past several years Petitioner has observed a rapid degeneration in "international goodwill" resulting from not only what is termed "LID" operating behavior and a total lack of social politeness, but violent on-air "frequency fights" and a proliferation of profane/obscene/vulgar unidentified licensee transmissions on both CW (Morse Code) and SSB (voice) modes. Equally horrific, have been the increased International packet cluster system postings involving multiple FORGERIES of FCC licensee callsigns (i.e., "Identity Theft").

8. The International packet cluster system has become an integral electronic part of amateur radio on-air activities involving the operating venues of "DX'ing" and "Contesting" (a/k/a "RadioSport"), and is meant to serve as a tool and positive, mutual information sharing venue for all participants.

9. To illustrate the severity of this matter, attached as EXHIBIT 1 is a list of randomly selected packet posts made over the past several months. Petitioner personally verified with FCC licensees WX3B, KY1V, W3UR, N4NN, K1ZM (on behalf of VY2ZM) and others who have unfortunately also been victims of callsign "Identity Theft", that they did NOT originate these FORGED postings made by the cowardly, Psychotic individual who has utilized multiple International anonymous Internet proxy servers to post NON-International Goodwill content foul trash. Clearly, many of these ongoing posts are a form of Electronic "Harassment" and "Stalking". Some of the postings constitute a form of "Electronic Hate Crime", which is believed to be the basis of all of the slanderous forgery posts targeting Mr. Jim Nitzberg, WX3B, who is of Jewish descent. Very disturbing, is that the perpetrator of these electronic crimes is most likely an FCC Amateur radio licensee.

10. As a former member of the FBI "InfraGard" program, Petitioner has spent countless hours in investigative research in this matter, and filed a formal Cybercrime Complaint with the Federal Bureau of Investigation including sufficient details for to enable the FBI to follow the "Electronic Breadcrumbs"


necessary to catch the perpetrator(s). Amendment of the rules as proposed is necessary to specifically define a "Federal Crime" for the purposes of full investigation, **CRITICAL ISSUANCE OF SUBPOENAS** and for full prosecution by the U.S. Attorney.

11. Amendments to the rules as proposed herein will also serve as a very strong deterrent against any similar future undesirable callsign "Identity Theft", electronic hate crimes, harassment and stalking within the amateur radio community.

12. The proposed amendment(s) are to be retroactively effective as of January 1, 2007.

For the reasons set forth herein, Petitioner requests The Commission issue a Notice of Proposed Rulemaking in this matter.

The following data unfortunately conveys the “worst of the worst” that has been taking place within the amateur radio related International packet cluster community by the Psycho Cybercriminal presumed to also be an FCC amateur radio licensee committing the forgeries.

Posting message content represents not only IDENTITY THEFT of current FCC licensees, but also bogus fabrications of what would be authorized FCC callsigns if not for the content of the callsign suffixes (i.e., K1ASS). The postings also represent a form of “Electronic Harassment” and “Electronic Stalking” of successful, well-known amateur radio operators within the DX’ing and Contesting (RadioSport) like WX3B, KY1V, W3UR, K1ZM and others. WX3B and VY2ZM (K1ZM) also experienced deliberate, on-air jamming by either CW (Morse Code) or solid carrier signals and modulated carrier signals. This deliberate interference has most likely been caused by the same Psycho Cybercriminal making the fraudulent and fabricated callsign postings.

Much of the posting content also constitutes electronic character assassination, hate crime (anti-Jewish, anti-Gay), racial and sexual solicitation terms along with the frequent use of obscene/profane/vulgar language in a forum venue which sadly can also be viewed by teenage or younger amateur radio operators. Some of Psycho Cybercriminal’s postings are tantamount operating an electronic adult bookstore in the middle of a high school campus.

In addition to the forgeries of current FCC licensee callsigns, a trademark of this criminal’s postings is the frequent, repetitive use of bogus/fabricated callsigns (or derivatives thereof) like B1TCH, AL0SER, and QU3ER as in the following examples of posts from 2007 and 2008:

I personally verified with W3UR that he never operated as KP1/W3UR or W5/W3UR, and did not make what on the surface appeared to be a “self-post” on December 28, 2007. Although the TI8II (Costa Rica) and OH2BH (Finland) callsigns belong to valid International amateur radio operators, I also verified with these individuals that these posts were also forgeries of their callsigns, which are but two examples of the antithesis of “international goodwill”, as will be very clear in many of the actual postings to follow herein including those targeting YV5ANF.

Some of the postings made by Psycho Cybercriminal have been a form of intentional “deceptive interference” to FCC licensees like WX3B, by the posting of frequencies on which WX3B was NOT operating, so as to misdirect potential RadioSport contacts away and prevent WX3B from making valuable contacts during these on-air operating events.

As will be most evident, additional “trademark” bogus callsign fabrications include ID1OT, MORON, L0SER, G4Y, H0MO, H0RNY, WX3QUEER, WX3GAY, and others as well as MO5SAD to mock the Israeli MOSSAD in the vulgar anti-Jewish posts made on Sept. 21, 2009.
