Dear Ms. Dortch:

Pursuant to Staff's request, Applicants hereby supplement the pending Application in the above-referenced proceeding to provide supplemental ownership information about Fibertech Networks, LLC ("Fibertech Networks").

Fibertech Networks clarifies that Nautic Partners, LLC ("Nautic Partners") administers several funds, including Chisholm Partners IV, L.P. and Fleet Growth Resources III, Inc., that hold a combined interest in Fibertech Networks of 51.9%. Nautic Partners does not hold any direct or indirect ownership interest in Fibertech Networks.

Chisholm Partners IV, L.P. ("Chisholm Partners") owns a 27.7% direct interest in Fibertech Networks. Chisholm Partners is controlled by its general partner, Chisholm Management IV, L.P. (a U.S. limited partnership), which in turn is managed and controlled, through a contractual agreement, by an investment committee comprised of three U.S. citizens: Habib Y. Gorgi, Robert Van Degna, and Bernard V. Buonanno III. Decisions of the investment committee are made by unanimous approval. Chisholm Management IV, L.P. and each of its investment committee members have offices located at 50 Kennedy Plaza, 12th Floor, Providence, RI 02903.

Fleet Growth Resources III, Inc. ("Fleet Growth") owns a 16.3% direct interest in Fibertech Networks. Fleet Growth is a wholly-owned subsidiary of Fleet Growth Resources, Inc., which in turn is a wholly-owned subsidiary of Bank of America Corporation, a widely-held corporation. Both Fleet Growth Resources, Inc. and Bank of America Corporation are U.S. companies with offices located at 100 North

Tryon St., Charlotte, NC 28255. Fleet Growth is managed, through a contractual agreement, by two U.S. citizens (Habib Y. Gorgi and Robert Van Degna) with equal authority to make decisions for Fleet Growth. As indicated above, Mr. Gorgi and Mr. Van Degna have offices located at 50 Kennedy Plaza, 12th Floor, Providence, RI 02903.

Banc of America Capital Investors SBIC, L.P. ("Banc of America SBIC") owns a 27.7% direct interest in Fibertech Networks.¹ Banc of America SBIC is controlled by its general partner, Ridgemont Capital Management SBIC, LLC. The sole member of Ridgemont Capital Management SBIC, LLC is Ridgemont Capital Management, L.P., whose general partner is REP I GP, LLC. Ridgemont Capital Management SBIC, LLC, Ridgemont Capital Management, L.P., and REP I GP, LLC are all U.S. entities formed in Delaware with offices located at 100 North Tryon St., Suite 2510, Charlotte, NC 28202. The managing member of REP I GP, LLC is J. Travis Hain, a U.S. citizen with offices also located at 100 North Tryon St, Suite 2510, Charlotte, NC 28202.

In addition, Banc of America Capital Holdings V, L.P. owns a 70.06% interest in Banc of America SBIC. The 99.5% owner of Banc of America Capital Holdings V, L.P. is BA SBIC Sub, Inc., which is a wholly-owned subsidiary of Bank of America, N.A., which in turn is a wholly-owned subsidiary of Bank of America Corporation, a widely held corporation. Banc of America Capital Holdings V, L.P., BA SBIC Sub, Inc., Bank of America, N.A., and Bank of America Corporation are all U.S. entities with offices located at 100 North Tryon St., Charlotte, NC 28255. Moreover, the general partner of Banc of America Capital Holdings V, L.P. is Ridgemont Capital Management V, L.P., a Delaware partnership with offices located at 100 North Tryon St., Suite 2510, Charlotte, NC 28202. The general partner of Ridgemont Capital Management V, L.P. is REP I GP, LLC, which, as described above, is also the general partner of Ridgemont Capital Management, L.P.

No other entity directly or indirectly owns or controls 10% or more of Fibertech Networks.

¹ Fibertech Networks inadvertently listed BancAmerica Capital Investors SBIC I, L.P. in the Application, but BancAmerica Capital Investors SBIC I, L.P. is currently known as Banc of America Capital Investors SBIC, L.P.
