Dear Ms. Dortch:

On behalf of Consolidated Telcom ("Consolidated"), this letter is to request an extension of time, until December 31, 2010, for a transition of BRS and EBS operations from the "old band plan" to the "new band plan."

On April 20, 2009, Consolidated filed with the Commission a letter notice of its plan to "self transition" the band plan for BRS and EBS in BTA113, Dickinson, North Dakota. It was anticipated at the time that the transition could be completed by October 20, 2010.

The transition has been delayed as Consolidated has sought to avoid a disruption of services to customers. It has taken more time than anticipated to implement alternative service plans, but it is expected that the transition will be completed by year-end.

There is no indication that any parties to the transition will be prejudiced by the requested extension. A copy of this request for extension is being served on the parties to the transition.
