**DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF  
VILLISCA FARMERS TELEPHONE COMPANY TO THE FARMERS MUTUAL TELEPHONE  
COMPANY OF STANTON, IOWA**

**NON-STREAMLINED PLEADING CYCLE ESTABLISHED**

On September 20, 2010, Villisca Farmers Telephone Company (Villisca) and The Farmers Mutual Telephone Company of Stanton, Iowa (FMTC) (collectively, the Applicants) filed an application pursuant to section 63.03 of the Commission's rules for the transfer of control of Villisca to FMTC.<sup>1</sup>

Villisca, an Iowa corporation, is an independent local exchange carrier (LEC) that provides local exchange telephone service and exchange access services to two exchanges (Villisca and Nodaway) in Montgomery, Adams, Page and Taylor Counties in southwestern Iowa. Villisca serves a total of approximately 834 access lines in these two Iowa exchanges. Villisca also resells intrastate and interstate long distance toll services within its local exchange service areas. RSA 1 Limited Partnership d/b/a Chat Mobility f/d/b/a Cellular 29 Plus (Chat Mobility), an Iowa limited partnership with wireless operations serving primarily small communities and rural customers in markets located in southwestern Iowa, including the exchange areas of Villisca and FMTC. Villisca owns a 7.62 percent limited partnership interest in Chat Mobility and a ten percent ownership interest in Cellular 29, Ltd. (Cellular 29), an Iowa corporation and the corporate general partner of Chat Mobility. Villisca's interests in Cellular 29, Ltd. is subject to a right of first refusal, which has been exercised by the partnership and the corporation, respectively, in connection with this proposed transaction.

FMTC, an Iowa corporation, is an independent LEC that provides local exchange telephone service and exchange access to three exchanges (Stanton, Bethesda and New Market) in Montgomery, Page and Taylor Counties in southwestern Iowa. FMTC services a total of approximately 992 access lines in these three Iowa exchanges. FMTC resells intrastate and interstate long distance toll services within its local exchange service areas. FMTC is an authorized dealer for the cellular services of Chat Mobility in the Stanton, Iowa area. FMTC owns a non-controlling 10.28 percent limited partnership

interest in Chat Mobility and a ten percent ownership interest in Cellular 29. FMTC has no other subsidiaries or affiliates that offer telecommunications services. Applicants state that no entity or individual has a direct or indirect ownership interest of ten percent or more in FMTC.

The proposed transaction consists of the acquisition of all of the issued and outstanding shares of common stock of Villisca by FMTC from the existing shareholders of Villisca. Villisca will continue to exist as an Iowa corporation, and as an incumbent LEC that provides interstate exchange access services and interstate interexchange services. After consummation of the proposed transaction and redemption of Villisca's limited partnership interest, FMTC will own an approximately 11.4 percent limited partner interest in Chat Mobility and an approximately 11.11 percent shareholder interest in Cellular 29.

The Applicants do not seek streamlined treatment for this application under section 63.03(b) of the Commission's rules because Villisca's Nodaway and Villisca exchanges are adjacent to FMTC's Stanton, Bethesda and New Market exchanges.<sup>2</sup> The Applicants assert the proposed transaction will promote and preserve competition in the domestic market and will not result in harm to competition in any relevant market.

### **GENERAL INFORMATION**

The application referenced herein has been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies. Interested parties must file comments or petitions to deny no later than **October 21, 2010**. Replies or oppositions to comments and petitions must be filed no later than **October 28, 2010**. All filings concerning matters referenced in this Public Notice should refer to **DA 10-1942** and **WC Docket No. 10-195**, as well as the specific file numbers of the individual applications or other matters to which the filings pertain.

Under the Commission's procedures for the submission of filings and other documents,<sup>3</sup> submissions in this matter may be filed electronically (*i.e.*, through ECFS) or by hand delivery.
