PROFESSIONAL BIOGRAPHY FOR SCOTT K. BERGMANN

Scott K. Bergmann is Assistant Vice President, Regulatory Affairs for CTIA – The Wireless Association®, where he is responsible for coordinating regulatory issues for the association affecting the wireless industry. These issues include universal service, intercarrier compensation, broadband, and spectrum policymaking. Mr. Bergmann has represented the wireless industry as a member of the Universal Service Administrative Company’s (“USAC”) Board of Directors since 2009, also serving on the High Cost-Low Income Committee.

Mr. Bergmann previously served for over 12 years at the Federal Communications Commission in a wide range of positions. Most recently, Mr. Bergmann served as the Senior Legal Advisor to FCC Commissioner Jonathan S. Adelstein. In this capacity, he served as chief of staff for all policy, legal, and administrative issues within the Commissioner’s office, and was directly responsible for matters involving broadband, rural telecommunications, universal service, consumer protection, disability access, and competition.

Prior to joining Commissioner Adelstein’s office, Mr. Bergmann served as Legal Counsel to the Bureau Chief and Deputy Chief of the Competition Policy Division in the FCC’s Wireline Competition Bureau. In these roles, he advised the Bureau Chief on matters including regulation of broadband services, telephone competition, public safety, and numbering. Mr. Bergmann started his career at the FCC as an Attorney-Advisor in the Industry Analysis and Technology Division of the FCC’s Common Carrier Bureau, focusing on universal service and broadband data collection issues. Mr. Bergmann received his B.A. from Duke University and his J.D. from the University of Southern California.
