Dear Ms. Dortch:

As required by 47 CFR 64.1120(e), Ace Telephone Company of Michigan, Inc. (ATCM) and Peninsula Telephone Company (PenTel), submit this correspondence to notify the Commission of an impending transfer of PenTel customers to ATCM. The affected customers are located in PenTel's Old Mission exchange.

1. **Names of Parties to Transaction:** Ace Telephone Company of Michigan, Inc., and Peninsula Telephone Company. ATCM is the acquiring carrier.
2. **Type of Telecommunications Service Provided to Affected Customers:** PenTel currently provides basic local exchange service, domestic toll, and broadband services to residential and business customers located in the Old Mission exchange, which is located in Michigan. ATCM will take over as the provider of these services to all customers in the Old Mission exchange.
3. **Date of the Transfer:** The planned transfer date is December 1, 2010, or as soon thereafter as all required regulatory approvals have been obtained.
4. **Notice Sent to Affected Customers:** Customer notification letters were sent to impacted customers via United States Mail on October 22, 2010. A copy of the customer notice is attached.

5. **Certification of Compliance:** ATCM hereby certifies compliance with the requirement to provide advance subscriber notice, in accordance with 47 CFR 64.1120(e)(3). ATCM will also comply with the other statutory and Commission requirements.




