
Dear Ms. Dortch:

CoBridge Communications LLC ("CoBridge"), pursuant to Section 64.1220(e) of the Commission's Rules (47 C.F.R. §64.1120(e)) hereby notifies the Commission that on or after December 16, 2010 CoBridge will assume Charter Fiberlink - Georgia, LLC's telecommunication subscriber customer base in the Fort Gordon, Georgia service area. The acquisition is part of the acquisition of the Charter cable system which serves the following areas in Georgia: Fort Gordon, Harlem, Grovetown, Richmond County and Columbia County. CoBridge provides the following information in respect to the transfer:

1. **Names of the Parties to the Transaction:** The parties to the transaction are Charter Fiberlink – Georgia, LLC, the transferor and CoBridge Communications LLC, the transferee.
2. **Types of Telecommunications Services Provide to the Affected Customers:** Facilities based local exchange and interexchange services.
3. **Date of the Transfer:** The parties anticipate that the affected customers will be transferred to CoBridge at midnight Eastern Standard Time on December 16, 2010, or as soon thereafter.



Important Notice Regarding Your Phone Service!

Dear Charter Telephone Customer:

On or after December 16, 2010, Charter Fiberlink - Georgia, LLC, which provides telephone service to you under the name Charter Telephone ("Charter"), will transfer its customers to another company, CoBridge Communications LLC ("CoBridge").

How will the transfer affect your rates and service?

Immediately following the transfer, you will continue to have the same telephone number and receive the same services at the same rates, terms and conditions as you do now. You will not be charged any fees for the transfer to CoBridge and CoBridge will be responsible for any carrier change fees that might apply as a result of such transfer to CoBridge. Notice of any future changes in rates, terms and conditions of service will be provided to you as required by law.

What are the next steps?

You don't have to do anything! Of course, you are free now or at any time to select a new service provider, but we are confident that you will be completely satisfied with CoBridge.

We anticipate the date for the transfer may be as soon as thirty (30) days from the date of this letter. If you have not notified Charter that you have arranged with another service provider for service to commence on or before the date of the transfer, you automatically will become a CoBridge customer for the telephone services you currently purchase from Charter.

If you have placed a preferred carrier "freeze" on your Charter services to prevent their unauthorized transfer to another service provider, FCC rules require that the freeze be lifted at the time of the transfer to CoBridge. At your request, CoBridge can reestablish preferred carrier "freeze" protection for your account after the transfer.
