Dear Ms. Dortch:

As requested by FCC staff, the Applicants in the proceedings captioned above hereby provide the following additional information to supplement their Applications. Unless otherwise noted, the meaning of each capitalized term is as defined in the Applications.

FiberNet and NTELOS lines to the customer premise in overlapping markets. In the markets in which both FiberNet and NTELOS provide services as CLECs, FiberNet runs its own fiber or other facilities to some but not all of the premises of the customers that it serves. In these same markets, NTELOS connects to some but not all of its customers on a Type I basis. However, in no instance does both FiberNet and NTELOS run their own facilities to the same customer premises. Furthermore, the Applicants note that in all instances, an ILEC or other

competitor connects on a Type I basis to each premise served by FiberNet or NTELOS with its own facilities. As Applicants have previously stated, FiberNet does not provide service in any markets in which NTELOS is an ILEC.
