Dear Ms. Dortch:

On November 16, 2010, Maureen O'Connell, Senior Vice President, Government Relations, News Corporation, Ron Wheeler, Senior Vice President, Content Protection, Fox Group and Rick Lane, Senior Vice President, Government Relations, News Corporation, met separately with (i) Edward Lazarus and Marilyn Sonn of Chairman Genachowski's office and Paul de Sa and Douglas Sicker of the Office of Strategic Planning and Policy Analysis; (ii) Dave Grimaldi of Commissioner Clyburn's office; and (iii) Brad Gillen of Commissioner Baker's office to discuss matters related to the above-referenced proceedings.

During the meetings, Ms. O'Connell, Mr. Wheeler and Mr. Lane described News Corporation's and Fox's concerns about the impact that an "all-vid" device would have on the critical need to protect audio-visual content against theft and unlawful distribution. Specifically, they made the points set out in comments and reply comments filed as part of these proceedings by the Motion Picture Association of America, Inc., of which Twentieth Century Fox Film Corp., a News Corporation company, is a member. They also discussed the points made in reply comments filed in these proceedings by the Joint Program Networks.

This letter is being submitted electronically in the above-referenced dockets, which have been granted permit-but-disclose status, pursuant to Section 1.1206(b) of
