Mr. Floyd has substantially complied with *Order* FCC 10M-15, released November 2, 2010, in his initial submission of documents. The *Order* intended, *inter alia*, to obtain documents that would sufficiently identify and describe Evans Broadcasting Company, Inc. ("Evans Broadcasting"), the intended assignee in bankruptcy. Mr. Floyd has responded in his *Objection and Responsive Submission* dated November 10, 2010, as follows:

The documents [identified in Docket sheet]
---- have been requested [and] upon receipt
they will be filed as a supplement to the
instant submission.

These documents relate to pleadings and documents filed in the Bankruptcy Court proceeding referring to and/or identifying and/or describing Evans Broadcasting. See *Order* FCC 10M-15, *supra* at 2. Having considered Mr. Floyd's initial submission, it now appears appropriate to modify and lessen the *Order's* requirement for pleadings and documents regarding Evans Broadcasting.

Accordingly, IT IS ORDERED that *Order* FCC 10M-15 IS MODIFIED to delete the third clause describing in the last paragraph that provides: "all pleading and documents filed on the Bankruptcy Court proceeding referring to and/or identifying and/or describing Evans Broadcasting Company Inc."

IT IS FURTHER ORDERED that in substitution, Eddie Floyd shall SUBMIT and SERVE as soon as practicable (but no later than **November 19, 2010**) pleadings and/or documents in Mr. Floyd's possession or control that are sufficient to identify and describe Evans Broadcasting Company, Inc. including but not limited to current officers and directors, businesses conducted, subsidiary and affiliate companies, and FCC licenses held.
