("Kemp"), on December 14, 2009, in MB Docket 09-189, RM-11564. In lieu of the allotment of FM Channel 296C3 at Kahuku, Hawaii, as proposed in the Notice of Proposed Rule Making, Kemp requests that FM Channel 296C2 be allotted at Kualapuu, Hawaii, as a first local service. The reference coordinates of proposed Channel 296C2 at Kualapuu are: 21-10-57 NL and 157-13-26 WL, at a site 19.4 km (12miles) west Kualapuu.

In addition, a pending upgrade application will also be considered a counterproposal in MB Docket No. 09-189, RM-11564. On August 10, 2009, Big D Consulting, Inc., submitted an application for FM Station KNAN, Nanakuli, Hawaii, to upgrade from Channel 294C3 to Channel 294C2. See File No. BPH-20090810ACM.
