Dear Ms. Dortch:

On September 23, 2008, Clearwire Spectrum Holdings II, LLC ("CSHII"), a wholly-owned subsidiary of Clearwire Corporation filed its Transition Initiation Plan for BTA Number 293: Miami-Fort Lauderdale, Florida. Pursuant to the Commission's Rules, that Transition is supposed to be completed by June 23, 2010. On September 30, 2008, WPSWP Licensing Corporation (then a subsidiary of Sprint Nextel Corporation, now renamed WPSWP LLC ("WPSWP")) and due to a Commission approved transfer of control, a wholly-owned subsidiary of Clearwire Corporation) (together CSHII and WPSWP referred to herein as "Clearwire"), filed its Transition Initiation Plan for BTA Number 469: West Palm Beach-Boca Raton, Florida. Pursuant to the Commission's Rules, that Transition was supposed to be completed by June 30, 2010. On July 15, 2010, the Commission granted Clearwire's request for an extension until January 15, 2011. Clearwire hereby requests a further extension of time to complete the Transition for both BTA 293 and BTA 469 until July 15, 2011.

Clearwire has been diligently working on completing these Transitions since they were each initiated. It obtained all of the information required under the Commission's Rules through research of the Commission's databases and through data provided by EBS licenses in response to Clearwire's Pre-Transition Data Request. As described above, Clearwire filed its Transition Initiation Plans with the Commission and sent its Transition Notices to all of the licensees in the BTAs, as required under the rules. Clearwire then prepared its Transition Plans and timely sent

the Plans out to all 2.5 GHz licensees within the Miami-Fort Lauderdale and West Palm Beach-Boca Raton BTAs. Clearwire has been working with the impacted licensees in these two BTAs since it initiated the Transitions. Due to the large number of licensees involved and the interrelationship of the two BTAs due to geographic location, negotiation of the Transition process and the necessary related agreements took a longer than expected time. The parties did reach agreement between themselves. Equipment has been ordered, but there have been some delays in that process. Specifically, there is a delay in delivery of the Transmitter power supplies which are coming from China and delay in delivery of decoders and modulators needed for certain receive site installations. To the extent possible, Clearwire has already begun the process of Transitioning some of the impacted licensees. To that end, and since this delay is clearly beyond Clearwire's control, it respectfully asks for additional time to complete the Transition process and to file its Transition Completion notice. Clearwire believes that no parties will be prejudiced by grant of this request and notes that it has served the relevant parties to both Transitions.
