ORDER

In response to Joint Prehearing Statement filed on December 2, 2010, a Prehearing Conference was conducted today on-the-record. Useful information and explanation concerning the ongoing Bankruptcy Court proceeding of Eddie Floyd were provided by counsel for Mr. Floyd and counsel for Wilks-Reno. Comments from Enforcement Bureau counsel were also heard and considered.

Having been sufficiently informed in the premises, and based on representations made in the Joint Prehearing Statement, litigation of this case ceases forthwith while the parties prepare to submit appropriate filings to dismiss Wilks-Reno as a party, with prejudice; and while Eddie Floyd seeks approval from a Bankruptcy Court to assign FM Translator Station K273AF for benefit of creditors, and seek *Second Thursday* relief from the Media Bureau. See 25 FCC 2d 1112 (1970)

Accordingly, in the interest of administrative efficiency and convenience of the parties, IT IS ORDERED that this case is STAYED, *sine die*.

IT IS FURTHER ORDERED that with cooperation and support of the Enforcement Bureau, Wilks-Floyd shall file by **January 19, 2011**, an appropriate pleading or pleadings for consideration by the Presiding Judge in ruling on pending Motion For Voluntary Dismissal And To Remove Wilks License Company-Reno LLC As A Party. Alternatively, a Joint Status Report shall be filed on that date.

IT IS FURTHER ORDERED that Eddie Floyd shall file a Status Report by **January 28, 2011**, and each 60th day thereafter, on the current state of Bankruptcy Court proceeding, and on the status of anticipated application of Eddie Floyd to the Media Bureau for approval of assignment of FM Translator Station K273AF pursuant to the *Second Thursday* doctrine. *Id, supra*.

IT IS FURTHER ORDERED that all now pending party Motions and Orders of the Presiding Judge on former instructions, procedures and discovery, ARE STAYED pending further *Order*.
