Please accept the enclosed 2,430 personal letters, and more than 77,600 petitions (sent to FCC Chairman Julius Genachowski) – gathered from citizens representing every state in the nation who oppose the Federal Communications Commission’s plan of seizing federal control of the Internet under the thin veneer of promoting “freedom” for all.
