**Re: City of Chesapeake Lease Administrative Fee, PS Docket No. 06-229**

Dear Admiral Barnett:

This letter updates the Public Safety Spectrum Trust's ("PSST's") letter of January 20, 2011, which indicated that the PSST did not receive the lease administrative fee from the City of Chesapeake, Virginia ("Chesapeake") by the extended payment deadline. By way of background, on November 5, 2010, the Public Safety & Homeland Security Bureau ("PSHSB") granted Chesapeake a 30-day extension of time to pay the lease administrative fee due to the PSST for administration of the long-term *de facto* spectrum lease between the PSST and Chesapeake.<sup>1</sup> On December 13, 2010, the PSHSB granted Chesapeake an additional extension of the payment deadline until January 14, 2011.<sup>2</sup>

The PSST has now received the lease administrative fee from Chesapeake. As shown in the attached copy of the envelope containing the fee payment, Chesapeake mailed its payment to the PSST on January 10, 2011. The delay appears to have been caused by a delay in mail service, not by Chesapeake's delay in mailing the payment.
