**MOTION
TO ACCEPT FILING AS TIMELY-FILED COMMENTS**

The California Public Utilities Commission and the People of the State of California (California or CPUC) hereby file this Motion to Accept Filing as Timely-Filed Comments and respectfully request that the Federal Communications Commission (FCC or Commission) accept the accompanying Comments of the California Public Utilities Commission and of the People of the State of California as timely-filed for the following reasons:

1. On February 14, 2011, the FCC released a Public Notice seeking comments on the Joint Section 214 Application of Blue Casa Communications, Inc. (FRN: 0018554444) ("Blue Casa"), Blue Casa (assignment for the benefit of creditors), LLC (FRN 0020570354) ("Assignee *FBD* Creditors"), and Blue Casa Telephone, LLC (FRN 0020552303) (Joint Application).
2. The Public Notice requested comments by February 28, 2011.

3. In response to the Public Notice, the CPUC timely prepared its Comments and attempted to electronically file the Comments yesterday.

4. Around 10:30 a.m. yesterday, the CPUC submitted the Comments electronically to the FCC and waited for a confirmation of the filing. The CPUC, however, did not receive a confirmation of its filing.

5. Around 2:45 p.m. in the afternoon, the CPUC re-filed the Comments and waited for a confirmation. However, again, no confirmation was forthcoming.

6. Because the CPUC did not receive any confirmation of its filing, the CPUC contacted the FCC's ECFS desk by phone and e-mail regarding the filing and requested a confirmation from them.

7. This morning, the CPUC received an e-mail from the FCC's ECFS help desk. They stated that the CPUC's Comments that were submitted yesterday did not go through.

8. The CPUC called the ECFS help desk back this morning and was told that the CPUC filing did not properly go through because there was heavy filing traffic at the FCC yesterday. The ECFS help desk advised the CPUC to re-file the Comments today.

9. Early this morning, the CPUC re-filed its Comments and received a confirmation sheet.

10. The CPUC also spoke to the FCC's Secretary's office about what happened with our filing yesterday and they advised us to re-submit the Comments today along with this Motion.

For all of these reasons, the CPUC requests that the FCC accept the accompanying Comments of the California Public Utilities Commission and of the People of the State of California as timely-filed.
